CONDITIONS OF MEMBERSHIP

4. Any MEMBERSHIP fees paid **WILL NOT** be refunded.
5. Management reserves the right to terminate or suspend memberships. Written notification will be provided in such cases.
6. Members are entitled to use social facilities and the bar area as permitted under the Liquor Licensing Act 1998.
7. Any member found causing wilful damage to any Club property, or found to have removed or misused Club property may be charged to the full extent of the law.
