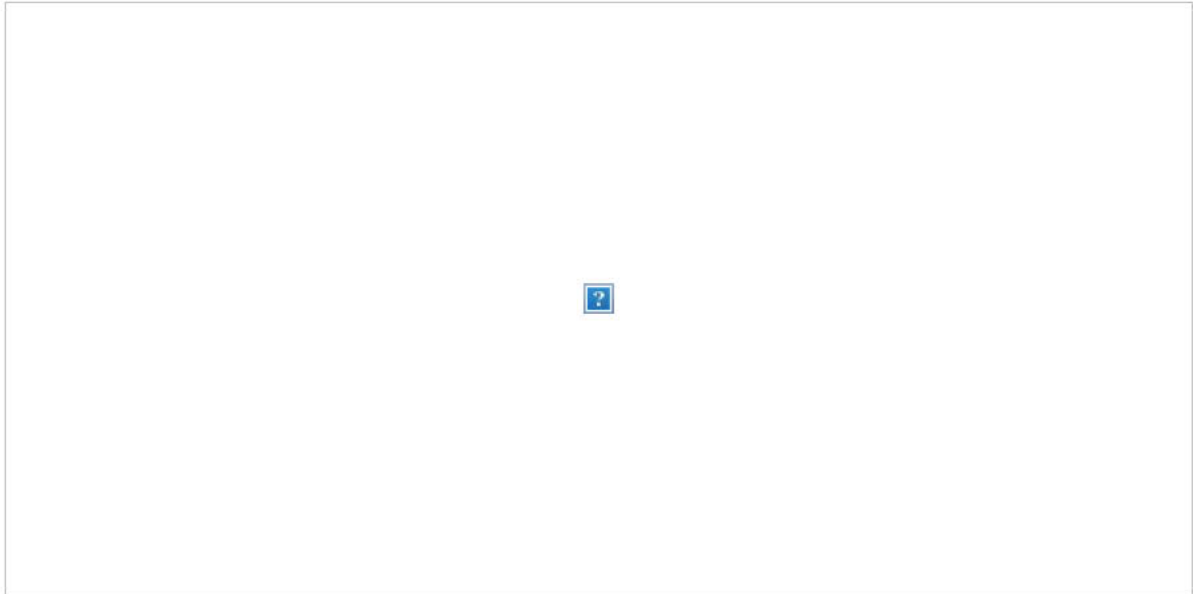

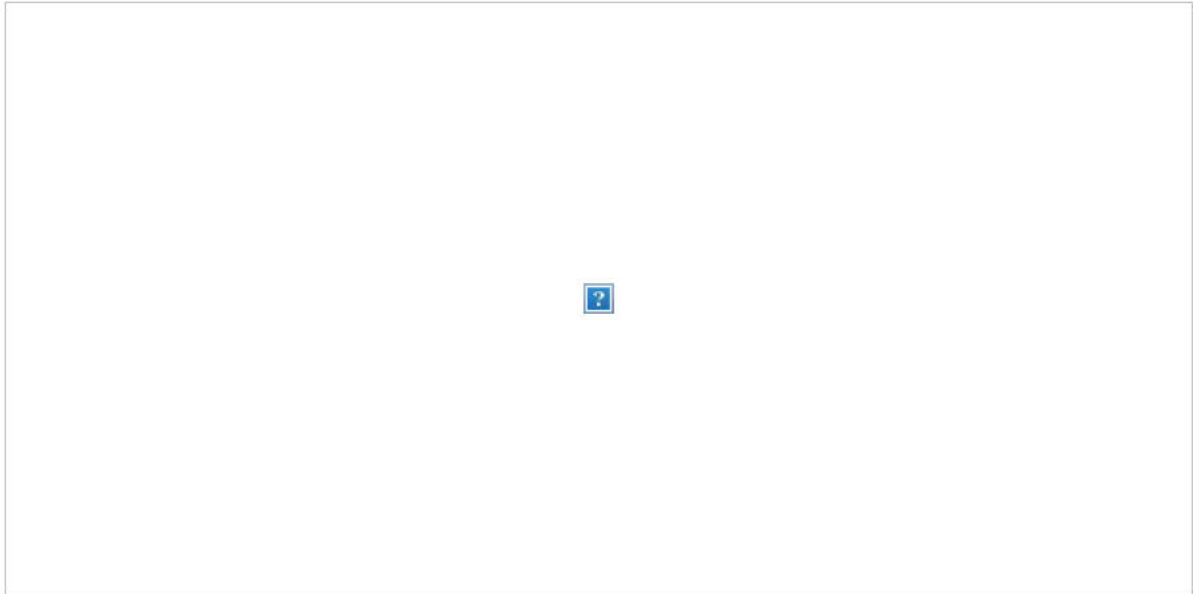

style juveniles they are currently housing have escaped to roam our property four times already. They have tried snapping at our dog through the fence. Which has made me increase the height and strength of the fence.

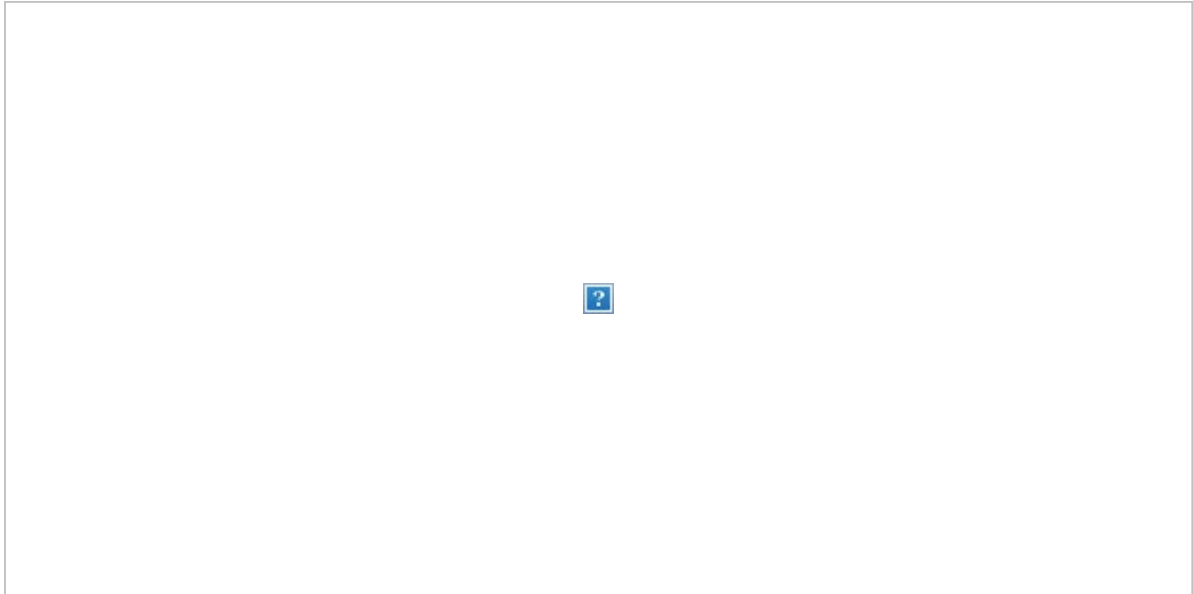
