Attachment 5.1A - Revised RRG 5-Year Plan

This report seeks endorsement of the updated RRG 5-Year Plan, which guides the Shire's forward works program for road preservation and renewal. The updated plan incorporates revised priorities based on current road-condition data, traffic loading, safety risk, and lifecycle cost modelling.

The Wheatbelt North Regional Road Group (RRG) coordinates regional funding allocations in accordance with the *State Road Funds to Local Government Procedures* and the *Roads 2040 Regional Strategies for Significant Local Roads*.

Funding is distributed on a two-thirds State / one-third Local Government basis through Road Project Grants. Each participating local government maintains a rolling 5-Year Plan to identify and prioritise projects according to regional significance, asset condition, and economic impact.

The Shire's current plan was endorsed by Council on 17 September 2024 and forms part of the Wheatbelt North RRG program. Over the past 12 months, further network inspections and geotechnical testing have revealed accelerated pavement distress on key freight and school-bus routes, warranting a reprioritisation of works.

#### Comment

The revised plan introduces several key adjustments:

- Sections of Tampu Road, Benjaberring Road, and Culbin Boreen Road have moved up the program due to increased heavy-vehicle movements and evidence of subgrade shear.
- Projects for the 2030/2031 financial year have been added to maintain a consistent rolling five-year pipeline, supporting long-term funding stability and alignment with the Shire's Asset Management Plan.
- Following advice from Main Roads WA and recent RRG technical reviews, the Shire will complete both seal coats within the same construction season to improve adhesion, surface integrity, and cost efficiency. This approach also eliminates the need for temporary traffic management over multiple years and reduces mobilisation costs by up to 10%.
- The plan integrates data from RAMM (condition rating), traffic counts, and geotechnical reports to rank projects on a weighted-scoring basis covering condition, connectivity, and economic importance.
- The updated priorities improve access for agricultural freight operators, emergency services, and school buses, particularly in the northern and eastern localities where deterioration has accelerated following the 2022–23 wet season.

Adoption of the revised RRG 5-Year Plan ensures the Shire's funding submissions remain competitive within the regional pool and that project delivery aligns with asset management principles, engineering standards, and community expectations.

Main Roads WA recently contacted all Wheatbelt local governments regarding the availability of surplus Regional Road Group (RRG) funding for shovel-ready projects deliverable within the 2025–2026 financial year. Eligible projects were required to be listed in each Shire's 2024 Road Strategy or on approved Commodity Routes, ensuring compliance with RRG funding criteria.

Given the short submission timeframe and current construction commitments, the Shire of Dowerin identified reseal works on Dowerin-Meckering Road as the most suitable shovel-ready project for completion this financial year.

The approved project covers a reseal (S45R - 14 mm) treatment from SLK 21.50 to SLK 23.84, connecting last year's reseal section (just before Hindmarsh Back Road) through to this year's RRG reconstruction section. Once complete, this will provide a fully upgraded and continuous section from town through to the Black Spot project.

#### Background

On receipt of Main Roads' invitation for shovel-ready projects, the Manager of Infrastructure and Projects undertook a rapid assessment of available and deliverable options within the Shire's current road program.

Given resourcing, timing, and readiness constraints, resealing was the most realistic and achievable project type that could be commenced and completed within the financial year.

A conservative submission was made for a short section of Dowerin-Meckering Road to ensure eligibility and deliverability within operational capacity. Main Roads WA has since confirmed funding approval for the project.

On 5 November 2025, the Shire received confirmation from Main Roads WA that the shovel-ready project had been approved, including the following funding allocation:

#### Comment

The total approved project cost is \$162,115, comprising:

- RRG Funding: \$108,077 (67%)

- Shire Contribution: \$54,038 (33%)

The works are scheduled for delivery in the current construction season and will form part of the Shire's annual bitumen preservation program.

This outcome represents a strong preservation investment in one of the Shire's highest-use freight routes, extending the service life of the pavement and maintaining network performance along a key link.

The project will be completed by the Shire's Works Crew in coordination with the annual bitumen program to optimise contractor mobilisation costs.

To enable delivery, the Committee's recommendation is sought to approve the additional capital expenditure of \$54,038, to be funded from the Road Reserve, which currently holds \$151,122. The physical transfer of funds from the reserve is not proposed until the mid-year budget review, at which time the Road Reserve will be replenished using the forecast operating surplus of the Municipal Fund.
