- 5. Management reserves the right to terminate or suspend memberships. Written notification will be provided in such cases.
- 6. Members are entitled to use social facilities and the bar area as permitted under the Liquor Licensing Act 1998.
- 7. Any member found causing wilful damage to any Club property, or found to have removed or misused Club property may be charged to the full extent of the law.
